MEMBERSHIP APPLICATION

1. MARC dues are \$20.00 per year, due in June of each year.
2. MARC meetings are the first and third Thursday of each month.
3. MARC has three repeaters:
 - A. 146.880 with PL 123.0 and auto phone patch.
 - B. 145.450 with PL 123.0.
 - C. 444.500 with PL 118.8.
4. MARC sponsors a directed net (Tri-State Two Meter Net) that is called up each Monday night at 8:00 P.M. on 146.880 MHz, with PL 123.0.
5. MARC operates AmCom-1, a converted bus that has HF, VHF, and UHF radios installed for use in emergencies. A 6 KW electric generator on a towed trailer, is used to provide emergency power. MARC has 2-meter and HF stations located at the Allegany County Emergency Management Center to provide communications with EOC personnel.

The Mountain Amateur Radio Club welcomes you to our organization, and hopes you will participate in our many functions throughout the year. Events include Field Day, Walk America, National Road Rally, fund raisers for Salvation Army and others, club picnic, Christmas party, ham radio classes, and emergency training.
